

# Anthem Blue Cross of California Announces the Termination of La Palma Intercommunity Hospital

**ATTENTION BLUECARD MEMBERS:** Blue Shield of California has not had a contract with La Palma Intercommunity Hospital since February 3, 2007. Therefore, BlueCard members will be impacted with the termination of La Palma Intercommunity Hospital from Anthem Blue Cross of California's networks.

Anthem Blue Cross of California has announced that effective August 1, 2009, La Palma Intercommunity Hospital will be terminated from their POS, PPO, HMO, PAR/Traditional and EPO networks. The reason for the termination of La Palma Intercommunity Hospital is due to being purchased by Prime Healthcare Services who declines to contract with many health plans.
