ATTENTION BLUECARD MEMBERS: The hospital listed below **does not participate with any carrier due to their closing.** BlueCard members will be impacted by this termination.

Century City Doctors Hospital announced that they will file a voluntary petition for debt protection from creditors under Chapter 7 of the Bankruptcy Code. As a result, effective August 22, 2008, the hospital closed its emergency department and has cancelled all elective surgeries. Over the next few days the hospital will begin transferring all non-dischargeable patients to nearby hospitals. The hospital expects to close its door by Friday, August 29, 2008. This will impact all lines of business: POS, PAR, PPO, HMO, and EPO.
